In case of the neglect of any person to pay the first one-half of the sum required by said real estate list and the said personal property list, until after **October 17, 2022**; you will add interest to so much thereof as remains unpaid at the rate of **4%** percent per annum, commencing **October 18, 2022** to the time of payment and collect the same with the tax remaining unpaid.

In the case of neglect of any person to pay the remaining one-half of the sum required by said real estate list, until after **April 18, 2023**; you will add interest to so much thereof as remains unpaid at the rate of **4%** percent per annum, commencing **April 19, 2022** to the time of payment and collect the same with the tax remaining unpaid.


